## FOURTH AMENDMENT TO PRIMARY DEDICATION, DECLARATION, PROTECTIVE RESTRICTIONS, COVENANTS, LIMITATIONS, EASEMENTS AND APPROVALS APPENDED TO AND AS A PART OF THE DEDICATION AND PLAT OF TUSCANY, SECTION 1, A SUBDIVISION IN PERRY TOWNSHIP, ALLEN COUNTY, INDIANA

This Fourth Amendment to Primary Dedication, Declaration, Protective Restrictions, Covenants, Limitations, Easements and Approvals Appended to and as Part of the Dedication and Plat of Tuscany, Section 1, a Subdivision in Perry Township, Allen County, Indiana (this "Fourth Amendment") is made effective as of the date this Fourth Amendment is recorded in the Office of the Recorder of Allen County, Indiana (the "Fourth Amendment Date").

WHEREAS, the Existing Property is encumbered by the Primary Dedication, Declaration, Protective Restrictions, Covenants, Limitations, Easements and Approvals Appended to and as Part of the Dedication and Plat of Tuscany, a Subdivision in Perry Township, Allen County, Indiana dated June 7, 2012, and recorded on July 3, 2012, as Instrument No. 2012036344 of the records of the Recorder's Office of Allen County, Indiana (the "Declaration"); and

WHEREAS, the Declaration was amended by a certain First Amendment to Primary Dedication, Declaration, Protective Restrictions, Covenants, Limitations, Easements and Approvals Appended to and as Part of the Dedication and Plat of Tuscany, a Subdivision in Perry Township, Allen County, Indiana dated December 29, 2012, and recorded on December 31, 2012, as Instrument No. 2012074352 of the records of the Recorder's Office of Allen County, Indiana (the "First Amendment"); and

WHEREAS, the Declaration was further amended by a certain Second Amendment to Primary Dedication, Declaration, Protective Restrictions, Covenants, Limitations, Easements and Approvals Appended to and as Part of the Dedication and Plat of Tuscany, a Subdivision in Perry Township, Allen County, Indiana dated July 12, 2013, and recorded on August 2, 2013, as Instrument No. 2013045031 of the records of the Recorder's Office of Allen County, Indiana (the "Second Amendment"); and

WHEREAS, the Declaration was fur	rther amended by a certain	n Third Amendment to

WHEREAS, the Members of each class of membership entitled to cast fifty-one percent (51%) of the votes of each such class of the Association, acting by and through the Board (the "Board") now desires to further amend the Declaration pursuant to the terms of this Third Amendment.

NOW, THEREFORE, in consideration of the mutual terms, covenants and conditions contained herein, the Board desires to amend the Declaration as follows:

- 1. <u>Definitions</u>. Any capitalized term not defined herein shall have the meaning ascribed to it in the Declaration, as amended by the First Amendment, the Second Amendment, and the Third Amendment. This Fourth Amendment is incorporated into and made a part of the Declaration, as amended by the First Amendment, the Second Amendment, and the Third Amendment, and any and all references to the Declaration hereafter shall include this Fourth Amendment. Any inconsistency or conflict between this Fourth Amendment and the Declaration, as amended by the First Amendment, the Second Amendment, and the Third Amendment, shall be governed and controlled by the terms of this Fourth Amendment.
- 2. <u>Amendment to Declaration</u>. <u>Article VIII, Section 1(p)</u> of the Declaration shall be deleted in its entirety and replaced with the following:

To enforce the provisions of this Declaration and any rules made hereunder and to enjoin and seek damages from any Owner for the violation of such provisions or rules. Without limiting the foregoing, the Board may, from time to time, adopt and thereafter impose upon Owners monetary fines ("Fines") for violations of this Declaration and any rules made hereunder, provided that the adoption of the Fines are subject to the notice, voting and quorum requirements as set forth in the Association's Articles of Incorporation and Bylaws, as same may be amended from time to time. An Owner's Fines shall be a charge on the Owner's land and shall be a continuing lien upon each Lot owned by such Owner. The Fines, together with costs of collection thereof, including without limitation, reasonable attorney's fees, shall be the continuing obligation of the Owner who is subject to a Fine. Article VI, Section 10 of the Declaration shall apply to Fines, as well as Assessments.

- 3. <u>Certification of Compliance</u>. The undersigned members of the Board certify, as evidenced by their respective signatures below, that this Fourth Amendment was approved by the authority and consent of the Members of each class of membership entitled to cast fifty-one percent (51%) of the votes of each such class of the Association, and that such consent is evidenced by a written instrument as required by Ind. Code § 32-25.5-3-9(2)(B).
- 4. <u>Miscellaneous</u>. Except as herein expressly modified, the terms and provisions of the Declaration, as amended by the First Amendment, the Second Amendment, and the Third Amendment remain in full force and effect.
